## **Business**

B. Executive Session concerning the current limited access agreement with a church member. - Entered at 7:05 Exited at 7:33pm. The Board determined that the member was in violation of the agreement and will be banned from entering the premises.

C. Ideas for Board Retreat in the on-line environment - brainstorming

The general consensus was that having the retreat for two days with one two hour session each day would be best for an online retreat. If more time is required, up to two sessions per day with a break between sessions and no single session lasting more than 2 hours.

Discussion included determining what training is most important to include? Which training is most effective with everyone present (synchronous), and what can be handled on an individualized basis. Some possible areas are learning how Policy Governance works. Discerning the mission and the ends. How the Council sets up the means by which we accomplish our stated goals. What policy governance is and is not. - How do we get engagement around revising our Board/Council Covenant? and eventually the whole congregation involved in discussing the Mission of the Church and the Church covenant.?

Using the online File Cabinet. Set our goals for the year. Setting up apprenticeships for roles such as treasurer and president board members. Manuals for committees. Responsible reporting requirements, budgeting. How to run events. Continuing work on Right Relations How to develop the right relations by using clear mission statements.
